## Mayor's Good Neighbor Quarterly Award Requirements

The Mayor's Good Neighbor Award recognizes Garland residents or property owners who have made an extraordinary commitment to improving the quality of life in their neighborhoods. The City of Garland is committed to creating Neighborhoods of Choice through community partnerships. The Mayor's Good Neighbor Award acknowledges the accomplishment of community partners and highlights the importance of all neighborhood stakeholders working together to make Garland a great place to work, live, and invest.

**Award Type:** Mayor's Good Neighbor Award

**Timeframe:** Quarterly

**Nominations:** An application process open to the public. Properties located within the City of Garland are eligible. Property can not have code violations, liens, or be owned by a city employee.

**Eligibility Requirements:**

- Nominee must be a resident or property owner in the City of Garland
- Nominee must have made significant improvements or upgrades to their property that provide a positive physical (aesthetic) impact to their Garland Neighborhood within the previous calendar year.
- Nominee must have demonstrated efforts beyond the basic property maintenance standards outlined in Chapter 32 of the Code of Ordinances.
- Nominee must not be employed by the City of Garland.
- Nominee must be current on city taxes and utilities.
- Nominee must not be involved in any litigation against the City of Garland
- Projects initiated by City of Garland staff are not eligible.
- Both residential and commercial properties are eligible for nomination.

**Considerations:** Property must reflect superior level of maintenance of the structure and the landscaping.

**Selection Process:** Nominations are received through the Mayor's office. A winner is selected each quarter. A picture must be provided with the nomination form.

**Award:** Award finalists will be recognized during a City Council meeting. The winner will be awarded an acrylic plaque presented by the Mayor and City Council members at a Council meeting; recognition in Garland City Press, online, and other media outlets; the quarterly winners and their project will be prominently featured at the Annual Neighborhood Summit.
